2025-2026 Snow Removal Services

Released: Tuesday, September 16, 2025

Bids Due: Friday, October 17, 2025

Scope of Services: The purpose of this agreement is to provide Nushagak Cooperative (hereinafter referred to as NETC) and the successful proposer (hereinafter called Contractor) with a mutually acceptable agreement to provide planned and emergency snow removal services on the NETC Compound.

Areas: Nushagak Cooperative Business Property: 557 Kenny Wren Road – 800 Kenny Wren Road, please see attached map.

Length of Agreement: This shall be an annual agreement limited to the snow removal season, commencing **October 18, 2025, and ending May 31, 2026**, inclusive. This agreement may be renewed on an annual basis by written mutual consent of both NETC and the Contractor.

This agreement may be terminated for cause, including failure to perform in accordance with any section of this agreement. In the event of failure to perform, NETC will provide written notice, which will be delivered by registered mail to the Contractor at the address referenced on the Request for Proposal that was submitted.

Insurance: Insurance shall be in such form as will protect the Contractor from all claims and liabilities for damages for bodily injury and property damage, which may arise from operations under the contract, whether such operation is by themselves or by anyone directly or indirectly employed by them. The certification of insurance shall be on file with NETC. All insurance shall be maintained at the expense of the contractor during the term of this contract.

Equipment: Equipment and manpower will be provided by the Contractor. All equipment shall be adequately equipped and outfitted to meet all local, state, or federal laws required for snow removal operations.

Operator: The Contractor shall ensure that the operator(s) provided are fully trained and properly licensed to operate their respective equipment.

Performance Requirements: Snow removal services will be requested if snowfall of more than 2" occurs. **Snow Removal services will be performed and completed outside of the normal operating business hours, prior to the start of the regular scheduled business day, excluding holidays recognized by NETC.**

Property Damage: The Contractor shall be responsible for any and all damage to private as well as public property (including public utilities) due to its own or its employee's negligence in performing snow removal operations.

Payment Schedule: Contractor shall submit an itemized invoice to NETC within 30 days of completed services. NETC shall make payment within 30 days of receipt of the invoice.

Selection: NETC reserves the right to retain the services of the Contractor who, in the opinion of NETC, can best provide the services requested under this agreement, including availability and condition of equipment, competency of operators, and previous experience.

BID PROPOSALS: For the proposal, the Contractor will submit an hourly rate. All proposals must be typewritten or printed in ink and properly signed by an officer of the company. If the submitted proposal is accepted by NETC and properly countersigned, it shall constitute a formal agreement between the Contractor and NETC with no further revisions, addenda, or exceptions acknowledged unless previously noted in writing on the proposal form. All required insurance certificates and additional requested information shall be submitted to NETC within 15 days of execution of the agreement, as requested by NETC.
